Car Parking Permits now open for renewal 2021/22



For the past 8 years Sevenoaks Town Council has made provision in its Raleys Car Park for low paid retail workers in the Town. The Town Council is offering 35 parking permits at £50 per annum. Applications are invited from workers in Sevenoaks Town who meet the following criteria:

1. Applicant must be a Sevenoaks Town worker from an independent retail premises
2. Application form must be co-signed by employer confirming salary
3. Permits are car registration specific
4. Permit will be valid from 01.04.2021 to 31.03.2022
5. Parking is permitted Monday to Friday only
6. Cost of permit is £50 per annum

NEW MULTI-MILLION FUND UNVEILED TO HELP MOST IN NEED



A further £10million of emergency funding is being rolled out to continue helping Kent's most vulnerable households and businesses hardest hit by the pandemic, Kent County Council announced today.

The Helping Hand Scheme includes a raft of support ranging from assisting just-managing families with heating bills and helping struggling firms stay afloat, to tackling digital poverty and match-funding crowdfunded community projects providing vital local assistance.

The scheme is the latest initiative to help people and businesses in Kent under pressure, because of Coronavirus restrictions, funded by the £95m Emergency COVID Grant awarded to KCC by government over recent months to help contain the outbreak.

Working with district and borough councils, and other key partners, KCC will distribute the latest tranche of money to relevant services and organisations to award to those most impacted by the current national lockdown.

The Helping Hand Scheme includes a range of targeted help, including:

- **£4m for low-income individuals and households and those in financial crisis** - which will be made available via council services such as the Kent Support and Assistance Service, as well as district and borough councils, voluntary and community organisations, including Kent Community Foundation, and utility companies, such as South East Water.
- **£3m for businesses and the self-employed** - which will be allocated through council services, district and borough councils, voluntary and community organisations, and business networks, including the Chamber of Commerce.
- **£2.5m to tackle digital poverty** - working with schools and colleges, district and borough councils and voluntary and community organisations, and
- **£500,000 to match-fund crowdfunded community projects** - that support local communities respond and recover from COVID.

- ☒ Are they offering you something that seems too good to be true?

HOW TO... STOP SCAMS

Tips to avoid scams and stay safe

- 1 . **Protect your personal information**, do not hand this out easily
- 2 . **Never send money to people you don't know**
- 3 . **Don't feel pressured to make a decision**, if you're unsure, it is okay to say 'No' and that you will seek advice first before hanging up
- 4 . **Strengthen your online security**, with online security software on your digital devices, create strong passwords, open websites with HTTPS
- 5 . **Don't open any unknown email or text message links**
- 6 . **Register with the free Telephone Preference Service (TPS)** to opt-out of cold calls

WATCH OUT FOR...Coronavirus Scams

During the Covid-19 outbreak and lockdown restrictions, there has been an increase in various scams. We urge you to remain vigilant.



NHS - VACCINE

If you've been contacted by email, text message or a phone call asking for your personal and bank details to pay for a vaccine - this is a scam.

NHS coronavirus vaccines are FREE.



HMRC - TAX REFUNDS & TAX FINES

Beware of emails, texts and phone calls from odd numbers requesting your personal and bank details to issue tax refunds and pay tax fines.



CLONE INVESTMENT FIRMS

Criminals have replicated existing investment company websites by obtaining their information from the Financial Conduct Authority (FCA).
