



TOWN TEAM UPDATE: (DECEMBER)

November turned out to be a very busy month for the Town Team, and indeed, the businesses and residents of Sevenoaks.

It opened with the Autumn Vegan Market which took place in Vine Gardens. It was pleasing to see that 27 traders arrived, coming from all over South East England and while vegan food was the main attraction there were stalls selling candles, perfumes, cork handbags and even bamboo toothbrushes!

During the market live music acts, provided by the Listening Room Music Agency, played on the bandstand and this greatly added to the ambiance of the event.

For those who like to plan ahead, the Spring Vegan Market will be at Vine Gardens again on Saturday 9th April 2022.



Many of the events in Sevenoaks are organised by others including the Fireworks. This year the attendance was magnificent, with 10,000 tickets sold. Sevenoaks Round Table organise and run the evening which includes a torchlit procession through the town before the bonfire lighting and display. While it is the Round Table's occasion Sevenoaks Town Council and Town Team help with the setting up and logistics.

The **Christmas Lights Switch-On** takes place on the last Friday in November and though a chilly night, there was a great turnout to launch Christmas this year. Revellers enjoyed several stage acts, a host of street food outlets, a funfair and of course Santa's Grotto.

Latest updates for businesses affected by Covid-19



This afternoon [Prime Minister Boris Johnson](#) held a press briefing announcing that England will be moving to plan B, while continuing to work closely with the Devolved Administrations. The measures announced include:

- **The re-introduction of guidance for everyone who can to work from home. This will be introduced from Monday 13 December.**
- **From Friday 10 December, face coverings will become compulsory in most public indoor venues, such as cinemas, theatres and places of worship. There will be exemptions in venues where it is not practical to wear one, such as when you are eating, drinking or exercising. For that reason, face masks will not be required in hospitality settings.**
- **From Wednesday 15 December (subject to parliamentary approval) the NHS Covid Pass on the NHS App will become mandatory for entry into nightclubs and settings where large crowds gather, including:**
 - Unseated indoor venues with more than 500 people
 - Unseated outdoor venues with more than 4,000 people
 - Any venue with more than 10,000 people.

The NHS Covid Pass can still be obtained with two doses but will be kept under constant review as the boosters roll out. Having considered the evidence since the emergence of Omicron, proof of a negative lateral flow test will also be accepted.

The Prime Minister also outlined as Omicron spreads in the community daily tests for contacts will be introduced instead of isolation. People are being advised to test using a lateral flow device, particularly before entering a high-risk setting involving people they wouldn't normally come into contact with, or when visiting a vulnerable person. Lateral flow devices remain free of charge and can be collected from local pharmacies.

The government will keep the data under constant review. The regulations are set to expire six weeks after implementation, with a review after three weeks. Guidance on [GOV.UK](#) will be updated to reflect these changes in the coming days.

HMRC Scams

HMRC scams can take place in a variety of ways and can be convincing. If you receive an email or text do not open attachments or links as they may contain malicious software or direct you to a misleading site.

Remember the HMRC will never ask you to click on a link requesting financial or personal information. Additionally, they will never telephone you and request you pay a fine by buying Gift vouchers.

Forward suspicious emails to phishing@hmrc.gov.uk or texts to 60599.

If you think that you may have been a victim of this type of scam, then contact your Bank immediately and report it to Action Fraud at www.actionfraud.police.uk or calling 0300 123 2040.

From 30 November 2021, there are some places where you must wear a face covering by law, unless you are exempt or have a reasonable excuse.



For full list of places see SCHEDULE 2 Relevant places PART 1 of [The Health Protection \(Coronavirus, Wearing Face Covering\) \(England\) Regulations 2021](#).

In England, you must wear face covering in the following indoor settings:

- Shops and supermarkets (places which offer goods and services for retail sale or hire).
- Shopping centres (malls and indoor markets).
- Auction houses.

- Post offices, banks, building societies, high-street solicitors and accountants, credit unions, short-term loan providers, savings clubs and money service businesses.
- Estate and letting agents.
- Premises providing personal care and beauty treatments (barbers, hair salons, tattoo and piercing studios, nail salons and massage centres).
- Pharmacies.
- Premises providing veterinary services.
- Retail galleries.
- Retail travel agents.
- Takeaways without space for consumption of food or drink on premises.
- Public transport (aeroplanes, trains, trams, buses, coaches and ferries), taxis and private hire vehicles.
- Any car or small van during a professionally delivered driving lesson, a practical driving test, or during one of the practical tests for giving driving instruction, and in all HGV lessons and tests.
- Transport hubs (airports, rail and tram stations and terminals, maritime ports and terminals, bus and coach stations and terminals).

FREE weekend parking before Christmas



Sevenoaks District Council is making its car parks free across the two weekends running up to Christmas - Saturday 11 and Sunday 12 and Saturday 18 and Sunday 19 December.

Visitors will be able to park for up to three hours in Bligh's Meadow and longer in other car parks, helping to spread the Christmas cheer as widely as possible.

There will be no need to show a pay and display ticket or log a stay with MiPermit for this offer.
